The Association was formed with the consent of British Gas & the BG Group, (now renamed to National Grid plc with a former name of Lattice plc), to provide a means of maintaining contact for former employees, in receipt of a pension, who live within the boundaries of the old British Gas Area of 'South Herts'.

1) About Us

Our Branch has a membership of just over 300 most of whom live in the counties of Hertfordshire and South Bedfordshire. 2) Membership
